Façade Rebate Program

The Hammond Urban Enterprise Association (HUEA) allocates façade rebate funds for all businesses located within the Enterprise Zone boundaries. The HUEA Executive Director and Board of Directors must review and approve the application before the commencement of the project. If the Board of Directors agrees to the zone business's façade improvements, the business will receive a specific allocation. *The project is subject to a visual inspection by the HUEA Board of Directors and staff.*

Priority consideration is given to:

1. Commercial/Retail store fronts.
2. Industrial office and manufacturing (includes expansions).
3. New construction.

After projects completion, the applicant must submit the following documentation:

1. Paid invoices.
2. Copy (front and back) of cancelled checks.
3. Photographs (before and after) of the project.

Eligible Businesses: Businesses located within the Hammond Urban Enterprise Zone

Eligible Projects: Exterior façade rehabilitation improvements
Landscaping

Application: When applicable, the contractor must obtain license and bond by the City of Hammond and all relevant permits apply. *Any project over \$300 requires a building permit.*

Rebate Criteria: Paid invoices.
Copy (front and back) of cancelled checks
Photographs (before and after) of the project
Completion and inspection of the project

Rebate Amount: reference compensation schedule

Approved Rebate Project Compensation Schedule

Eligible Project Cost	Rebate Amount	Max% of Rebate
\$1 to \$5,000	\$1,000 or 50% of Total Cost (the lesser one)	50%
\$5,001 to \$10,000	\$1,500	30%
\$10,001 to \$20,000	\$2,500	25%
\$20,001 to \$50,000	\$3,500	17.5%
\$50,001 and up	\$5,000	10%

Rebate is amount of dollars shown or percentage (whichever is less)

Additionally, the Hammond Urban Enterprise Association Board of Directors and staff reserves the right to increase or decrease the amount of rebate based on the projects favorable impact or project deviation from original description. Failure to apply and receive all appropriate permits results in NO REBATE. Eligible project costs are those related to façade improvements and landscaping only.
